Officers are required to make a formal declaration about Council contracts where the employee has a financial interest in accordance with the LGA 1972, S. 117.

Members must generally declare a disclosable pecuniary interest which he or she has in any item on the agenda. A Member with a disclosable pecuniary interest may not participate in any discussion on the matter at the meeting and must not participate in any vote taken on the matter at the meeting. In addition, the Council's Standing Orders require a member with a disclosable pecuniary interest to leave the room where the meeting is held while any discussion or voting takes place.

- 3. To receive, consider and record Councillors' requests for DPI dispensation (Section 31 Localism Act 2011) in connection with items on this agenda.** Applications for this must be made in writing to the Clerk prior to the meeting.
